REMARKS

CURRENT COVID-19 GUIDELINES ISSUED BY THE MINISTRY OF HEALTH

INDUSTRIES, MANUFACTURERS AND SERVICE PROVIDERS CAN INCREASE THEIR WORKFORCE TO 30% MAX (FROM 17.03.2020 UNTIL 19.04.2020 - 15% MAX) OR UP TO 10 EMPLOYEES SIMULTANEOUSLY IN THE PLACE OF WORK, WHICHEVER IS HIGHER.

PLACES OF WORK AND BUSINESSES THAT SATISFY THE "PURPLE BADGE" RULES CAN HAVE A BIGGER WORKFORCE (UP TO 100%), IF THEY:

APPOINT A CORONAVIRUS SUPERVISOR ON BEHALF OF THE EMPLOYER. PRACTICE STRICT HYGIENE MEASURES. ONLY TWO EMPLOYEES CAN SHARE A ROOM OF UP TO 20 SQUARE METERS - OR A LARGER NUMBER OF EMPLOYEES, IF THERE IS A PARTITION BETWEEN EMPLOYEES THAT PREVENTS SPREADING OF RESPIRATORY DROPLETS. A ROOM THAT IS LARGER THAN 20 SQUARE METERS CAN ACCOMMODATE NO MORE THAN 5 EMPLOYEES OR A LARGER NUMBER OF EMPLOYEES IF THERE IS A PARTITION BETWEEN EMPLOYEES. MEETINGS AND CONFERENCES ARE PERMITTED IF THERE ARE NO MORE THAN 8 EMPLOYEES IN THE SAME ROOM.

BUSINESSES THAT ARE ALLOWED TO OPERATE:

SUPERMARKETS, GROCERY STORES, BAKERIES, FOOD SELLING STORES PHARMACIES, STORES THAT PRIMARILY SELL HYGIENE PRODUCTS, OPTIC STORES, ANIMAL FOOD STORES, VITAL HOME MAINTENANCE SERVICES, APPLIANCES, COMMUNICATION AND MEDICAL DEVICES PRODUCTS AND SERVICES.

BUSINESSES WILL OPERATE, WHILE MAINTAINING A DISTANCE OF 2 METERS BETWEEN COSTUMERS, MARKING OF CHECKOUT AND LINE STANDING PLACES, PREVENTION OF CROWDING, SO THERE WILL BE NO MORE THAN 4 CUSTOMERS AT EACH CHECKOUT AT THE SAME TIME.

THE BUSINESS SECTORS THAT HAVE BEEN APPROVED FOR RE-OPENING UNDER THE CONDITIONS OF THE "PURPLE BADGE":

INFORMATION AND COMMUNICATION EQUIPMENT; AUDIO AND VIDEO EQUIPMENT; COMPUTERS AND ELECTRONIC ACCESSORIES INCLUDING SOFTWARE; TEXTILES; METAL TOOLS; PAINTS AND GLASS; FLOORING, CARPETING, TILING, AND WALLPAPER; FURNITURE; HOUSEHOLD APPLIANCES AND GOODS (NOT INCLUDING TOYS AND GAMES); CULTURAL AND LEISURE EQUIPMENT; BOOKS; NEWSPAPERS; OFFICE SUPPLIES AND STATIONARY; SPORTS AND BICYCLE EQUIPMENT; MUSICAL INSTRUMENTS; MUSIC AND MOVIE SALES; MEDICAL ACCESSORIES; LAUNDRY SERVICES; CLOTHING AND SHOE REPAIR SERVICES.

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 26.04.2020 AMENDMENT:

TAKE-AWAY AND DELIVERY FROM RESTAURANTS IS PERMITTED. RESTAURANTS MAY BE OPENED IN ACCORDANCE WITH NO SEATING IN RESTAURANTS

OPENING OF STORES IN PUBLIC SPACES IS PERMITTED UNDER GUIDELINES. MALLS REMAIN CLOSED.

HAIRDRESSERS, BEAUTY SALONS AND COSMETIC SERVICES MAY BE OPENED UNDER GUIDELINES.

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 04.05.2020 AMENDMENT:

STARTING 04.05.2020, ADDITIONAL ACTIVITIES AND BUSINESSES ARE PERMITTED, INCLUDING LIBRARIES, ALL KINDS OF NON-MEDICAL BODILY TREATMENT, ALTERNATIVE MEDICINE, HOTELS AND GUEST HOUSES, NATURE RESERVES, NATIONAL HERITAGE SITES, AND NATIONAL PARKS, ZOOS, AND SAFARIS. FURTHERMORE, IT IS PERMITTED TO OPEN SWIMMING POOLS FOR COMPETITIVE ATHLETES AND THERAPEUTIC ACTIVITIES. MALLS, MARKETS AND GYMS REOPENED ON 07.05.2020.

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 19.05.2020 AMENDMENT:

RESTAURANTS, BARS AND CLUBS WILL OPEN 27.05.2020 ACCORDING TO GUIDELINES. SWIMMING POOLS WILL OPEN 27.05.2020 DEPENDENT ON THE APPROVAL OF THE GOVERNMENT TO CHANGE THE REGULATIONS. HOTELS (INCLUDING DINING ROOMS AND POOLS) REOPENED ON 27.05.2020 AND ACCORDING TO RESTAURANT AND POOL GUIDELINES.

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 06.07.2020 AMENDMENT:

CLOSING EVENT HALLS, CLUBS AND BARS; RESTAURANTS - LIMIT OF UP TO 20 PEOPLE IN ENCLOSED SPACES AND UP TO 30 PEOPLE OUTDOORS WITH DISTANCE BETWEEN TABLES; CLOSING OF GYMS AND PUBLIC SWIMMING POOLS; CLOSING OF CULTURAL EVENTS; HOTELS AND TOURISM: CLUBS AND BARS WILL NOT BE PERMITTED ON THE HOTEL GROUNDS. RESTAURANT AND DINING ACTIVITIES UP TO 20 PEOPLE IN ENCLOSED SPACES WILL BE PERMITTED. HOUSES OF WORSHIP - UP TO 19 PEOPLE; OTHER GATHERINGS - UP TO 20 PARTICIPANTS, 2 METERS APART FROM EACH OTHER WHILE WEARING MASKS; ORGANIZED SPORTING EVENTS WILL ONLY BE POSSIBLE WITHOUT AN AUDIENCE (NO CHANGE FROM THE EXISTING SITUATION); BUSES - UP TO 20 PEOPLE PER BUS. THE GOVERNMENT AUTHORIZES THE MINISTER OF TRANSPORT TO DETERMINE ANOTHER NUMBER WITH THE CONSENT OF THE MINISTER OF HEALTH AND THE NATIONAL SECURITY COUNCIL (EFFECTIVE IMMEDIATELY); AND THE WORK OF GOVERNMENT MINISTRIES AND GOVERNMENT COMPANIES - AT LEAST 30% OF STAFF SHOULD WORK FROM HOME, ACCORDING TO RULES TO BE SET BY THE CIVIL SERVICE COMMISSIONER

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 13.07.2020 AMENDMENT:

REOPENING OF GYMS AND PUBLIC SWIMMING POOLS.

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 17.07.2020 AMENDMENT:

GENERAL RESTRICTIONS (SEVEN DAYS A WEEK): CLOSURE OF GYMS AND STUDIOS FOR EXERCISE OR DANCE, EXCEPT FOR USE BY COMPETITIVE ATHLETES, AS DEFINED IN THE ORDER. RESTAURANTS AND EATERIES TAKEAWAY AND DELIVERY ONLY, NO ON-SITE SEATING. RESTAURANTS AND EATERIES IN HOTELS - THE NUMBER OF PEOPLE PRESENT WILL BE LIMITED TO 35% OF THE MAXIMUM NUMBER ALLOWED IN ORDER TO PERMIT THE CONTINUED OPERATION OF THE HOTEL.

WEEKEND RESTRICTIONS (TO TAKE EFFECT FROM 17:00 ON FRIDAYS UNTIL 05:00 ON SUNDAY):

DURING THE WEEKEND, STORES, MALLS, OPEN-AIR MARKETS, HAIR SALONS/BARBERSHOPS, BEAUTY PARLORS, LIBRARIES, PETTING ZOOS, MUSEUMS AND DISPLAY SPACES, POOLS, TOURIST ATTRACTIONS AND CABLE CARS SHALL BE CLOSED. THIS RESTRICTION SHALL NOT APPLY TO STORES PROVIDING ESSENTIAL SERVICES: PLACES FOR THE SALE OF FOOD, PHARMACIES AND STORES MOST BUSINESS OF WHICH IS THE SALE OF HYGIENE PRODUCTS, OPTICIANS AND LABS FOR THE REPAIR OF COMMUNICATIONS DEVICES.

EMERGENCY REGULATIONS (ACTIVITY RESTRICTIONS) - 13.09.2020 AMENDMENT:

EFFECTIVE 18.09.2020 FROM 14:00 AND UNTIL 11.10.2020 AND SUBJECT TO AN ASSESSMENT OF THE MORBIDITY SITUATION, STEPS TO BE TAKEN:

- BUSINESSES THAT DO NOT RECEIVE THE PUBLIC AND WHICH PROVIDE ESSENTIAL SERVICES MAY CONTINUE OPERATING ACCORDING TO THE OUTLINE TO BE PRESENTED BY THE FINANCE MINISTRY.

- THE FULL CLOSURE OF ALL BUSINESSES THAT RECEIVE THE PUBLIC IN THE FIELDS OF COMMERCE, CULTURE, RECREATION AND DOMESTIC TOURISM, INCLUDING SWIMMING POOLS. GYMS AND RESTAURANTS (EXCEPT FOR ESSENTIAL SERVICES, PLACES FOR THE SALE OF FOOD, PHARMACIES, OPTICIANS OR STORES THAT DEAL MOSTLY IN HYGIENE PRODUCTS, STORES FOR ESSENTIAL HOME MAINTENANCE PRODUCTS, COMMUNICATIONS PRODUCTS AND MEDICAL DEVICES).

BUSINESSES, INCLUDING RESTAURANTS, SHALL BE PERMITTED TO OPERATE DELIVERY SERVICES ONLY.

- MOVEMENT IN LEAVING ONE'S HOME SHALL BE RESTRICTED TO 500 METERS, EXCEPT FOR ESSENTIAL NEEDS TO BE DETAILED IN THE REGULATIONS.

- CLOSURE OF THE EDUCATION SYSTEM, EXCEPT FOR SPECIAL EDUCATION, BOARDING SCHOOLS AND ADDITIONAL EXCEPTIONS AS DETAILED IN THE LEGISLATION REGARDING SPECIAL AUTHORITY IN DEALING WITH THE CORONAVIRUS (REMOTE LEARNING WILL BE ENABLED AS MUCH AS POSSIBLE).

- GATHERINGS RESTRICTION OF GATHERINGS ACCORDING TO THE COLOR RED IN THE
